Introduction

This Participant Information Sheet tells you about this research project. Knowing what is involved in the research will help you decide if you want to take part.

What is the research about?

The aim of this research project is to assess the effectiveness and efficiency of the current Family Relationships Services Program (FRSP) and its ability to meet the needs of families.

The FRSP provides a range of support and education services for separated and separating parents with the aim of improving the wellbeing of Australian families. These form part of a broader range of services available for separated and separating families (adults and children) in the family law system. This research will help us to understand the needs of separated and separating families and whether services funded under FRSP are meeting these needs.

The research program supporting the Review also includes a survey of separating or separated adults, in depth interviews with separating or separated adults who have used family law system services as well as those who have not used these services, and administrative data from service providers.

An online, anonymous survey is one part of the Research supporting the project and is the purpose of the following participant information sheet. More information is provided below.

Who is involved in the project?

In September 2023, the Australian Attorney-General, the Hon. Mark Dreyfus KC MP, announced that Andrew Metcalfe AO will lead a review of Family Law Services, focusing on those services funded under the Government's FRSP.

The Australian Institute of Family Studies has been commissioned and funded by the Australian Attorney-General's Department to undertake research between late October 2023 and June 2024 that will inform this Review and this survey is an important part of this research.

Why have I been invited to participate?

You have been invited to participate because we would like to understand the views and experiences of the broad range of professionals involved in managing, operating, and providing services under the Family Relationship Services Program, together with professionals involved in referring clients to these services or providing other family law system services to separating or separated clients.

Participating in this research might benefit you, as sharing your knowledge, ideas, and experiences might be empowering through fostering collaboration and contributing to potential change and improvements of service delivery.

Participation in this survey is completely voluntary. You can leave the study at any time, and it won't change your relationship with the researcher(s) or anyone else.

To the extent possible, your participation in this research will be kept confidential. No-one apart from the research team will know you have participated. If you do decide to leave the study, you will need to do this by emailing FRSPreview@aifs.gov.au

What will the researchers do and when?

As part of this research, the researchers have provided a survey link to consenting individuals. The link will direct consenting individuals to an anonymous, online survey. If you would like to participate, please open the link on the next page of this document.

Surveys are available early November (now) and must be completed before 1 January 2024. Consenting participants will be able to complete the surveys at a time and location that is convenient for them, though the research team advise participants to complete surveys in a quiet and private location.

Most questions in this survey will ask you to select a response from the options provided. There are a small number of questions that allow you to provide a comment. Please do not provide any information that may identify you in the questions requiring a comment.

What will happen to my information?

Your information will be used to inform a final research report.

We take your privacy and personal security seriously and safeguards are in place to protect it.

Any information that is obtained in connection with this research project and that can identify you will remain confidential unless otherwise permitted by you, or as required by law. The procedures for ensuring the confidentiality of your information during the collection phase and the later publication of results include:

- To the extent possible, your participation in this research will be kept confidential. Any information that you
 provide will be treated confidentially within the limits of the law. No-one apart from the research team will know
 you have participated.
- No identifying data will be collected in this survey. Participants are asked NOT to include any identifiable information, or information that may potential identify them, in their survey responses. If any identifiable or reidentifiable information is provided, it will be identified in the verification process and deleted from the survey responses so that it is deidentified and anonymised.
- You are free to stop the survey at any time, to not answer any questions and to delete your answers prior to submitting your responses.
- Our project report will only include the de-identified/anonymised survey data.

It is important that you know there is a limit to confidentiality. For example, if you tell us about any unreported current illegal activity, unreported abuse, or disclose something that makes us concerned for your safety or the safety of another person, then we may be obliged to pass this information onto the relevant authorities.

The Australian Government, Attorney-General's Department will retain the Intellectual Property in the data.

If the Attorney-General authorises the release of the public research, you will be provided with a shorter summary of the research results. Please let us know if you do not wish to receive the summary.

What are the potential risks?

It can be upsetting to talk about the experiences of separated/separating families. We have listed the contact details for some supports at the end of this sheet. Contact details for support services are also provided at the start and end of the survey. We have also given you a copy of our protocol guidelines. These have more information on available support if you become distressed or upset.

Additionally, you are free to stop the survey at any time, to not answer any questions and to delete your answers prior to submitting your responses.


Data storage and security

 - Regional Family Dispute Resolution
 - First Nations Family Dispute Resolution
 - Family Law Counselling
 - Children's Contact Services
 - Post Orders Program/Post Separation Cooperative Parenting Program
 - Supporting Children after Separation Program
 - Family Law Pathways Network
- an executive or staff member of a service provider organisation operating any of the above Family Relationship Services Program services
- a family law system professional including:
 - a lawyer
 - a judicial officer/registrar or other employee of the Federal Circuit and Family Court of Australia or Family Court of Western Australia
 - a family report writer/single expert
 - an employee of a Legal Aid Service (including Family Advocacy and Support Service (FASS) or Community Legal Centre
 - a private Family Dispute Resolution Practitioner or mediator
 - a Domestic and Family Violence Professional
 - a counsellor or other therapeutic professional who provides services in private practice to adults or children in separated families
 - a professional involved in the provision of family dispute resolution support through online mechanisms
 - a professional who is involved in parenting support programs, including through online mechanisms.
